To qualify for a License to practice as a General Medical Doctor/General Aesthetic Medicine Doctor/ Medical Specialist/Medical Consultant/General Dentist/Dental Specialist/Dental Consultant in Dubai Healthcare City (DHCC), the applicant must comply with:

- 'Healthcare Professionals Licensure General Requirements Guidance for Applicants' ; and
- The specific profession's minimum requirements listed below.


